





# MCS Approved Installer Scheme overview

**This scheme guide sets out the requirements your business needs to be recognised by NICEIC as technically competent to design, supply and install renewable technologies.**

The following technologies are included within NICEIC's MCS Approved Installer scheme:

- Solar heating (MIS 3001).
- Solar photovoltaic (PV) (MIS 3002).
- Heat pumps (air and ground source) (MIS 3005).
- Electric energy storage system (EES) (MIS 3012).

Being a part of the scheme will enable your customers to access government incentives such as:

- Boiler Upgrade Scheme (BUS).
- Home Energy Loan in Scotland.
- Smart Export Guarantee (SEG).



# Who is the scheme for?

The NICEIC MCS Approved Installer scheme is for businesses undertaking the design, supply and installation of renewable technologies.

MCS Standards and scheme documents have been designed with input from product and installer representatives, consumer groups, and technical experts from across industry. These can be accessed [here](#).

The MCS Approved Installer scheme will enable your business to register installations on the [MCS Installation Database](#) to raise MCS certificates. These MCS certificates are often required by your customers to access funding.



## Two for the price of one

This scheme and other NICEIC schemes, including the NICEIC Competent Person scheme, can be bundled for no extra cost.

This will allow your business to self-certify work and notify the local building control body through the [NICEIC Online Certification System](#). You will also save time and costs as your NICEIC assessment for both schemes will take place at the same time.



# Let's get you certified

**Applying for NICEIC schemes is a straightforward process. Your business will need to submit an online application form, pay an application fee and undergo an assessment against the requirements of the NICEIC MCS Approved Installer scheme.**

In your application, you'll need to disclose your contracting address – the place where you carry out and/or manage work included in the scope of certification, and where post can be sent – to meet the requirements of the Economic Crime and Corporate Transparency Act.

This must be a physical location. Virtual offices, PO boxes and digital office platforms are not acceptable.

You will need to complete an online application form and submit your application with your relevant insurance documents and Technical Supervisor's qualifications. Your application will not progress if you have not uploaded your insurance and qualifications information.

A fully completed application must be signed by the main contact on behalf of the business for each contracting office that required certification.

Along with your fully completed application form and supporting documents you will be required to pay a non-refundable application fee. At this stage your application details will be passed to MCS to complete scheme checks.

Once your application has been verified as meeting the requirements of the scheme, we will arrange an assessment.

You are not permitted to use our scheme landmarks until certification has been achieved.



# Your assessment

## Your assessment is a fundamental part of your business certification with NICEIC.

It allows your business to display the NICEIC scheme landmark with pride knowing that your business has met the high standards that people expect from NICEIC-certified businesses.

It is your chance to show that your business:

- has insurances, documentation and records in place to support you and your customers.
- carries out work that complies with the relevant industry standards.

It also gives you an opportunity to ask your Assessor any technical questions you might have.

Your NICEIC Assessor will need to meet two key people: your Technical Supervisor and your main contact. In some businesses the same person can fulfil both roles.

Being fully prepared for your assessment is the key to a good outcome. We're here to help you every step of the way. Please review our comprehensive [assessment guide and checklist](#) for more information.



## Certification

Once your assessment is completed by the Assessor, and validated, we'll give you the results. If your business is certified, you will receive a certificate and gain access to the many benefits being a NICEIC-certified business brings (see page 6) or visit our [website](#).

Your business's details will be uploaded to MCS at [mcs-certified.com](https://mcs-certified.com). You will also be able to display the MCS Scheme landmark, to help promote your business and notify completed installations to the Microgeneration Installation Database (MID). Your customers will also now be able to access government funding once you have completed installations on their behalf.

## Once your business is certified

To give assurances to your customers that your business is continuing to comply with the requirements of the relevant scheme rules, your business will require surveillance assessments, normally at annual intervals.
